INQUIRIES

You Asked

Can the money in a trust fund be withdrawn for an emergency and then put back?

Our Answer

The **funds held in trust** are for the **purposes of sponsorship**. It is very important that the funds are not touched for the duration of the application process, and only accessed once the refugee(s) arrive in Canada. IRCC may request updated account statements for funds held in trust at any time during the application process to ensure that the sponsors have not used the funds.

You Asked

What information needs to be included in the letter from sponsors who are involved in multiple applications, explaining how they are able to support the current application given their prior commitments?

Our Answer

At a minimum, the sponsors should identify all active applications they are currently involved in and all information that will assist the Officer when assessing settlement capacity. This includes:

- How the sponsor plans to divide their time between the applications;
- What logistics are involved (Do they drive? How long it will take the sponsor to travel to the refugees?);
- Any volunteers or family members that can assist them;
- What is their schedule like (Do they work? How many hours of free time do they have per day/week?);
- What responsibilities they have for each application; and,
- What the other members of the group will be doing.

IRCC recognizes that not all of the refugees will arrive at the same time. However, sponsors are advised to include information on what the sponsor will do, or what their plan is, if refugees do arrive at the same time. It is in the interest of the sponsor to include as much information as possible to satisfy the Officer that the plan is plausible and likely to be implemented.

Joint Assistance Sponsorship (JAS)

Many In-Canada JAS Refugees are waiting to be sponsored!

FAMILY SIZE: One

This young woman arrived in Canada last year and struggles to integrate into Canadian society due to traumatic events she experienced in her country of origin.

Needs: She has many mental health and behavioural issues including PTSD and anger management issues. These have slowed her ability to socialize and attend English classes. She has had counselling and medication for her mental health concerns, yet progress remains slow. She feels isolated from the broader community. She cares for her elderly mother and younger siblings who are dealing with their own trauma. This creates additional pressure and affects her ability to resettle.

A sponsor could: provide necessary social and emotional support to the young woman and reduce her feelings of isolation and loneliness; help her practice her English; help with her inclusion in the broader Calgary community and therefore with a sense of belonging; help her find resources in the community; and, provide additional guidance through formal systems such as schooling, employment, health care and public transit. This would help her gain independence, confidence and the agency to build a new life in Canada.

Refugees sponsored under the **Joint Assistance Sponsorship (JAS)** program have special or enhanced needs that will likely result in a longer or more difficult period of integration in Canada, due to:

- **Trauma from violence or torture;**
- **Medical disabilities;**
- **The effects of systemic discrimination; or,**
- **Being a large family unit (such as a single parent with several children).**

Under the JAS program, the government and private sponsors support refugees for up to 24 months, depending on the needs of the resettled refugee. In a few cases, the private sponsor may support refugees for up to 36 months. These refugees receive income support from the Government of Canada. They are matched with a private sponsorship group to help them adjust to life in Canada with settlement help and emotional support.

Some refugees are identified overseas for the JAS program due to their special needs. Others are converted into JAS cases after they arrive in Canada if it becomes clear that they need more support.

JAS refugee profiles can only be picked up by SAHs and their Constituent Groups.
