NOTE RE CAR ALLOWANCE:

Effective: January 01, 2025

If the allowance paid to the priest is based on a flat-rate that is not related to the number of kilometres driven, it is a **taxable benefit** and should be included in the priest's income.

Priest's may be able to claim **allowable expenses** on their tax return.

***Note- Priests who have not served full 25 years and do not qualify for full pension may elect to pay into the Pension Plan**
